Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: Dark green fine crystalline powder. The toxicological properties of this material have not been fully investigated. **Caution!** May cause eye and skin irritation. May cause respiratory and digestive tract irritation.

Target Organs: No data found.

Potential Health Effects

Eye: May cause eye irritation. This product contains a cationic dye. Similar dyes have caused permanent injury to the cornea and conjunctiva in documented exposure cases with human or rabbit eyes.

Skin: May cause skin irritation.

Ingestion: May cause irritation of the digestive tract. Low hazard for usual industrial handling. The toxicological properties of this substance have not been fully investigated.

Inhalation: May cause respiratory tract irritation. Low hazard for usual industrial handling. The

toxicological properties of this substance have not been fully investigated.

Section 4 - First Aid Measures

Eyes: Flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid.

Skin: Flush skin with plenty of soap and water for at least 15 minutes while removing contaminated clothing and shoes. Get medical aid if irritation develops or persists. Wash clothing before reuse.

Ingestion: Never give anything by mouth to an unconscious person. Get medical aid. Do NOT induce vomiting. If conscious and alert, rinse mouth and drink 2-4 cupfuls of milk or water.

Inhalation: Remove from exposure to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid if cough or other symptoms appear.

Section 5 - Fire Fighting Measures
