Section 4 First Aid Measures

Emergency and First Aid Procedures

Inhalation: IF INHALED: Remove victim to fresh air and keep at rest in a position comfortable for breathing.

Steps to Take in Case Material Is Released or Spilled:

Exposure to the spilled material may be severely irritating or toxic. Follow personal protective equipment recommendations found in Section 8 of this SDS. Personal protective equipment needs must be evaluated based on information provided on this sheet and the special circumstances created by the spill including; the material spilled, the quantity of the spill, the area in which the spill occurred, and the expertise of employees in the area responding to the spill. Never exceed any occupational exposure limits. Persons not wearing appropriate protective equipment should be excluded from area of spill until clean-up has been completed.

Environmental Precautions:

Avoid breathing material. Avoid contact with skin and eyes. Reduce airborne dust and prevent scattering by moistening with water. Ventilate the area by opening door and/or turning on fans and blowers. Avoid runoff into storm sewers and ditches that lead to waterways. Absorb spill with inert material (e.g., dry sand or earth), then place in a chemical waste container.

Handling: Do not breathe dust/fume/gas/mist/vapors/spray. Wash thoroughly after handling. Avoid release to the environment. Wear protective gloves/protective clothing/eye protection/face protection.

Storage: Store locked up. Suitable for any general chemical storage.

Storage Code: Keep container tightly closed in a cool, well-ventilated place. White - Corrosive. Separate acids from bases; separate oxidizer acids from organic acids.
